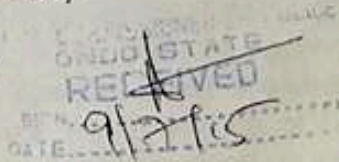

**REPORT OF THREAT TO LIFE AND INTIMIDATION BY MR.  
ADENIYI MALACHI COKER**

On the 8<sup>th</sup> of July, 2015 following the attempt to get Mr. Malachi arrested by operatives of the Nigeria Police Force who I understand came from Abuja, Mr. Malachi Coker believing that the arrest must have been instigated by my political ally Hon. Gbenga Edema against whom he contested for the seat of Ilaje constituency II Ondo State House of Assembly, began to call to threaten that he will snuff life out of me and Hon. Gbenga Edema.

Mr. Malachi Coker at about 11:51am of 08/07/2015 called me with GSM Number 08066614442 where in he threatened to kill me no matter where I may be in Ondo State and that I should not venture to come to Igbokoda otherwise I should consider myself dead. He even informed me that he has perfected plan to eliminate Hon. Gbenga Edema and I should desist from associating with him otherwise I do so at my own peril.

He also repeated this calls through this number 08188698188 at about 4:12pm repeating the same message. When I informed Hon. Gbenga Edema of this fact he also confirmed to me that somebody used the said GSM Number to call his line at about 4:10pm, 4:14pm 4:24pm threatening that he would deal with him.



I undertake to bear the cost of forensic examination of the call log evidencing this conversation.


I urge you therefore to save my soul by inviting Mr. Malachi Coker to come and explain why he wants to deal with Hon. Gbenga Edema and also to kill me.
