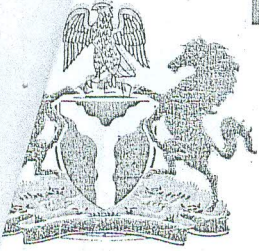
2. This decision was taken by the Commission in compliance with the Judgment of the Tribunal and that of the Court of Appeal.

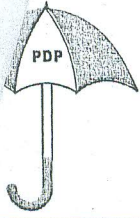
