Re: Executive summary regarding Nigeria tapes
Nov. 12, 2014

Guardian Consulting Group LLC was engaged on Nov. 10, 2014 to conduct forensic examinations on an audio recording purported to be a private discussion between a number of known Nigerian officials regarding election related activities.

We conducted two tasks: First, we compared the voices from the private tape to known samples of people reported to have been in that room in an attempt to identify them within a degree of scientific certainty; second to judge the veracity of selected parts of the conversation to a degree of scientific certainty.

Executive Summary of findings:

IDENTIFICATION

The following voices from the private tape were subjected to a Forensic Voice Frequency Comparison against a known sample and were found to match to a 98% degree of certainty:

- **Governor Avo Favose**
- **Senator Iviola Omisore**
- **Hon. Abdulkareem**
- **Caleb Olubolade**

The following voice was subjected to a Forensic Voice Frequency Comparison against a known sample and was found to match to an 80% degree of certainty:

- **Senator Musiliu Obanikoro**

VERACITY

- **Gov. Ayo Favose was being truthful when he said: *...there is no vehicle that left this place without that sticker.***
- **A person identified as Obanikoro with 80% of certainty was judged to be completely truthful when he said to a person identified as Abdul Kareem: *If am a happy man tomorrow night, the sky is your limit, and at the end of the day if am unhappy...I am not here for tea party, am on a special assignment by the president.***
- **A person identified as Abdulkareem with a 98% degree of certainty said: *i was the one who created road blocks, I was the officer on ground sir.***)

We found that more than 90 percent of the conversations reviewed were truthful.

DETAILS

The sample reviewed was provided to Guardian Consulting and is identified as ID#002 for filing purposes.

These are the known samples for which comparisons were made and identified to a 98% certainty:

The following identification is made to 80% certainty due to low quality of the audio portions both in the sample and the identified sample.

Methodology:

The findings are based on audio analysis, measuring the exact voice undulations and micro tremors utilizing each sample from both recordings. It should be noted that our voice analysis system does not measure pitch and tone. The system measures audible and inaudible frequencies that are released when a subject speaks. These frequencies from each sample are charted in a voiceprint, which displays unique characteristics. As

per above, four of the individual voiceprints were identified to a 98% degree of certainty and one to a certainty greater than 80%.

It may be possible to increase the degree of certainty on the **Musiliu Obanikoro** if more filtering and more samples were acquired. Let us know if you require that work.
