Enjoy the rest of your day, I ll speak to you tomorrow.

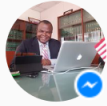
You checked the wrong place

Apparently, you hired me to register a magazine and you and someone else were checking for the registration of companies at CAC. Will you let me do my work or will interfere ?

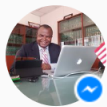

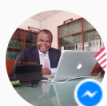

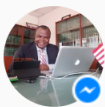

For the name registration?

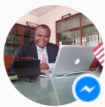
Let me explain to you. Once a magazine is registered for SSNR number, that name of the magazine cannot be used as a business name by anybody. That is why the CAC keeps record of names of all registered magazine



It doesn't mean that CAC registers Magazines

OK SIR

It only maintains the list of names of magazines so that companies do not register with such names. It only means that the names of magazines are not available as company names for companies wanting to register



However, CAC does not register names of magazines.

It is also dangerous to use CAC list for checking Magazines because CAC only

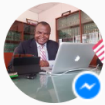

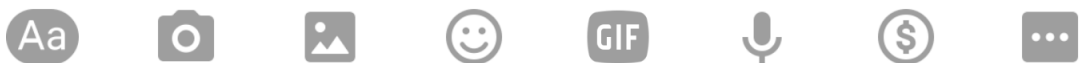

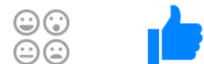

It was available for you. But one you took it, it is no longer available for anybody else that goes to check

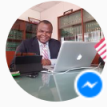

You asked me to check back today to know if the name is available and if you were able to reserve it.

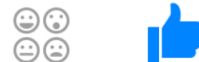

I queued your question. I will get to it. You knew I was sick during the weekend. Today is my first working day in the week and I had to be in court. I was in a meeting when you called. I

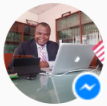
was in a meeting when you called. I would get to you. Patience requires you give me reasonable time

But please is there a proof of registration you can give to me so my manager can take it to NUJ tomorrow.




Otherwise we won't be given pass for the Coronation, and I need the pictures for the magazine
