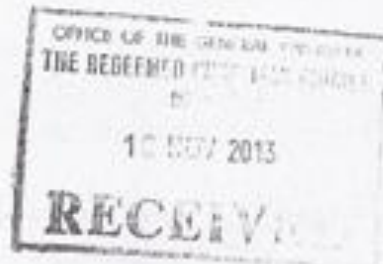

Greetings Sir in the name of Jesus Christ the Lord.

Sir, following the letter on the above subject matter dated 3rd November, 2013 and received by the office of the General Overseer on November 4, 2013, I was subsequently called and met with an Elder representing the Mission on Wednesday 14th November, 2013 at the RCCG Secretariat, Redemption Camp.

Sir, part of the fallouts of that meeting was that my sudden resignation in the Mission without notice was being interpreted at certain quarters that perhaps I had committed a sin which I knew could be exposed hence warranting my sudden resignation to avoid its consequences.

Sir, I immediately dismissed this insinuation and affirmed that my resignation from the Mission had nothing to do with this.

However sir, I will like to state here that I willingly submit myself for scrutiny by the Mission and in all the places where I had served in the Mission.



Grace and peace be multiplied unto you sir, in Jesus name.




It is our belief that the house will be of use to the Mission.

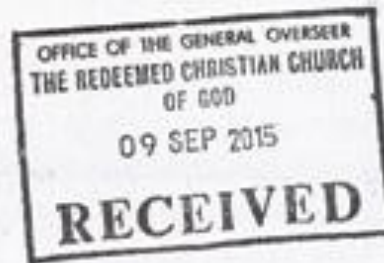

May the grace, peace and love of God be yours always in Jesus name.

Kindly accept our congratulations sir, on the recently concluded 63rd Annual convention of the RCCG. It is our prayer that the All-Sufficient God will always be there for us all, at all times in Jesus name.

Sir, we want to appreciate your kind understanding and prayer for our release more so, that it was coming after 23 years stay in the church and having risen to the position of Asst. Provincial Pastor (APICP). We are grateful for your kind release, even as we perceived that it was rather a difficult one. The positive testimonies of the past year have reinforced the fact that your prayers for the new assignment have started yielding positive results to the glory of God. Principal among these are the several hundreds of souls that have been gained into the kingdom of God, over a thousand unemployed youths and women groups

from over 30 denominations and people in other religion who have been empowered through our skills acquisition and entrepreneurial programme. Also, we have been involved in medical missions and outreaches to rural communities where several lives have been impacted positively, among others. To God be the glory.

However, sir, we want to place on record certain things that followed our exit and also communicate this to you for your information and attention.

1. Sir, upon our exit, we voluntarily left the keys to our house in Redemption Camp on Plot 15 Diligence Road, for the church in line with the policy of the church. This is a 5-Bedroom house- all en suite- estimated at Fifteen Million, Five Hundred Thousand Naira (N15.5 Million) as at December 2011. A firm of chartered Estate Surveyors & Valuers carried this out. (copy of valuation report attached). To the glory of God, we have no regret releasing the house even though we have no other one of ours as of date. This became possible as God gave us direction and grace to do so. We did not remove even a light bulb or pumping machine in the house talk less of any other important items. To our consternation, no mention of this has been made ever since. Not even an acknowledgement, or any form of compensation. Sir, we may want to know if this is the practice for those who at one time or the other had voluntarily left the Mission by resignation or relocated abroad and had houses at the Redemption Camp.
2. We (My wife, children and I) served the RCCG Mission for 23 unblemished years. We gave our best, assisted in planting over Twenty churches locally and three internationally; served on the Board of Christ Redeemers' College Sagamu, Ogun State, Nigeria for Fifteen years and chaired its Building & Technical Committee for over Ten years – a period that witnessed the massive renovation, remodeling and construction of new buildings – unprecedented till date. Several Millions of Naira passed through us, yet we gave account till the last kobo- a fact which was acknowledged with a letter from the College Board. We contributed immensely in the Construction of the present Dominion Cathedral Gowon Estate Ipaja, and Sunrise Parish Building Ijaiye, both in Lagos – from the scratch to


completion. Designed, coordinated the present Provincial offices and Chalets at Redemption camp and several other innumerable local church buildings of the RCCG both at home and abroad free of charge, among several other exploits. I see all this as a privilege to serve God as a trained professional and all the glory must be given to God.

Upon our divine exit, one would have expected a form of send forth at least if not from the National Headquarters- as a National staff, Lagos Province 25- the Province we served for 5 years as APICP, or Gateway parish, Ijaiye Lagos. Till date, nothing of such has been done, almost 2 years after! What was our offence? One may want to find out. Sir, we hereby acknowledge a cheque sum of One Hundred and Fifty Thousand Naira (N150, 000) sent by LP 25 during the inauguration of Life Anchor Ministry in July 2014. For this we are grateful. But is this all we deserve or is that in lieu of send forth? One may also want to find out.

Sir, we are not too sure all our previous mails - about six of them, got to you as we never had response to any till date. Your response to this one will assure us of its delivery. If however, we do not get any response, we will take it that it did not get to you sir, and we may be left with no other option than to find a way of drawing your kind attention to it.



We would like to remind and inform Daddy G.O of the following:



BACKGROUND & APPOINTMENTS

At the inception of Christ The Redeemer's College, CRC in 1995, the Board of Governors appointed me based on recommendation to coordinate the take-off of the projects through a letter dated 2nd April, 1996. A monthly token of N30, 000 was approved which was just enough for the running cost. The task was so enormous that I had to leave my practice at that time. To God be the glory, it was a successful endeavour and this necessitated the Board to recommend me as a Board Member, which was graciously approved by the proprietors of the College. I served on this Board from 2nd April, 1996- 9th July, 2012 when the entire Board was dissolved. To God alone be all the glory.

My assignment as a project coordinator came to an end on 1st October, 1996 after I had informed the Board of my intention to travel out of the country. A letter of appreciation dated 20th September 1996, and appointing a new project coordinator was given to me. However, when the idea of travelling out did not materialize, I continued to serve in the Technical committee, giving my fullest cooperation and support to the new appointee.

On 28th November 2009, the Board of Governors at its sitting again gave me the 'task of overseeing the details of the work to be done on a week by week basis.' This, I believe was as a result of the enormity of work to be done at that time with the benefit of hindsight. I accepted this onerous responsibility despite my schedule of work. I sought and got approval to employ a site staff to assist me on the job. He was in charge of the site workers while I supervised the day to day construction works in the College. We gave our best to it and to the glory of God; there was a major turnaround in the College's projects execution.

Some the College buildings were renovated. These include: 9 staff apartments including the Principal's house. Others include: Boys and Girls hostels, CRSA block of classrooms, among others. New buildings (Gate House and Multipurpose Hall) were designed by me and built during this period, internal roads from the main academic block- leading to the boys hostel, and also from academic block to the Principal's house were paved with interlock- done on site, hedges were created and major spaces landscaped and tendered. With the help of God, my architectural company, Sharon Rose Design Ltd., served as a major platform for actualizing these dreams.

I also mobilized colleagues in the allied professions- Structural Engineers, Mechanical & Electrical Engineers and Quantity Surveyors to perform their consultancy roles especially on the Multi- purpose Hall and Gate House, built at the total cost of N33, 547,196.00. Because of my involvement, a token sum of N200, 000 was paid to these professionals to cover incidentals on the drawings made for the initial extension. **Ordinarily on these two projects, the sum of over Three Million Naira would have been expended on consultancy services.**

A new set of drawings were produced for the New Dining Hall when a decision was taken by the College to extend it. This was prepared by me.

By God's special grace, I was able to make savings of another **Three Million, Three Hundred and Fifty Eight Thousand, Nine Hundred Naira (N3, 358,900.00)** for the College through negotiations and valuations of work done on just two of the contracts earlier awarded before I


was asked to take over the job of Project Coordinator. The attention of the last Board of Governors was drawn to this.

Considering the involvement and time spent on CRC projects at the second appointment, I hereby put forward an amount which I believe is reasonable. This was arrived at with the fear of God and with every sense of professional integrity. In view of this, I request for the payment of the sum of **Two Million One Hundred and Forty Thousand, Six Hundred and Four Naira, Sixty six kobo only** (Please see the breakdown below)

I would like to use this medium to remind you sir uptill date no communication has been made to us with respect to the pending issues raised in the said letter.


These are twofold:
