- 3.05 In his contributions also Mallam Nafiu Tukur Bello of DSS, informed members that they should go ahead and write their report to the State Government as the Prison Service had denied the Panel access to the Maximum Prison.
- 3.06 After a thorough deliberations on the matter, members resolved collectively to write its report and submit to Government.

The meeting was adjourned around 3:25 p.m. to reconvene Tuesday 9th April, 2019 with a closing prayers said by Nafiu Tukur Bello.
