Brought the two names to me as a registrar in the school to register the names bearing Adeleke Ademola and Adeleke Sikiru, but I requested for their passport but he told me that he will soon bring their passport. After paying the money to the T.S.A he then brought the passport for the Album and other necessary document such as template form etc. By the time he first bring their money for the registration which is ₦18,000, I then took the money to my boss or principal in order to pay it to the bank together. Although we did not ^{see} ~~view~~ them until the time of capturing and thumb printing, when two of them came for capturing although we are very surprised to see them on that day. But when the examination started around first week of June 2017, Only Adeleke Sikiru present for the examination throughout. We could not see Ademola Adeleke in the examination Hall. Both of them registered for 9 subjects each. Then I asked from Mr Sikiru where about of the partner he said he was busy and that he cannot come again. He is the only one that surfaces in the examination hall. Most of the time if I went to the Hall to see the supervisors and the invigilator ^{30/7/18} ~~invigilator~~ _{not}

Vacant. But when the result come out we
Went to the MECO Office to collect the result
computer sheet. In merely went through the
result slip, we discovered that Adeleke Ademo
has pass in some of the subject and has above
2 or ~~absent~~ in the result. This baffled me
and my principal. but we did not make any
official report towards the result to MECO
Authority. To the best of my knowledge nobody
~~to~~ wrote examination for Ademola Ade
leke.

sat for the examination, I saw
Sikiru Ademola in the Hall doing
