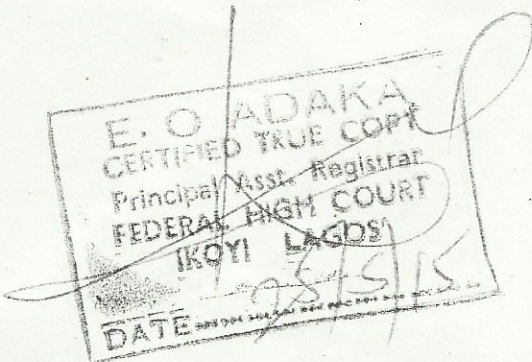

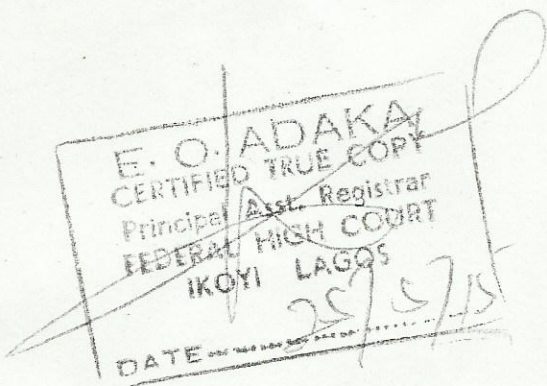
ORDER

UPON THIS MOTION EX-PARTE dated and filed on the 25th May, 2015 coming before the Honourable Court and praying as follows.

1. **AN ORDER** directing the Respondents by themselves their agents, subordinates and officers to release the Applicant unconditionally within 2 hours of the service of this order upon them pending the hearing and determination of the Originating Motion on Notice commencing this committal proceeding .

5. **AN ORDER** requiring the Respondents to show cause by statement on oath filed within 48 hours of service of this order upon them why the court should not find them guilty of criminal contempt as charged in this application.



6. **AN ORDER** granting the Applicant leave to serve the originating processes and all other process meant for service in this suit on the 1st Respondent outside the jurisdiction of this Honourable Court may deem fit to make in the circumstances.
5. And for such further order or orders as this Honourable court may deem fit to make in the circumstances.

AND UPON READING the affidavit in support of the motion ex-parte sworn to by **Chinedu Mbata**, Male, Nigerian, Christian, Litigation Executive, of Plot 1228 Ahmadu Bello Way, Victoria Island, Lagos and filed at this Court Registry.

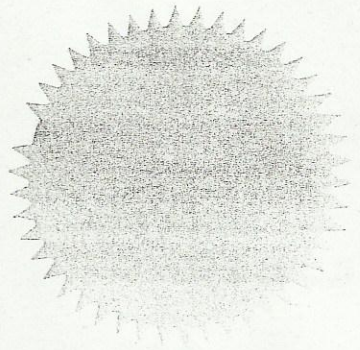
AND having carefully considered the application.
