You have to question the person who directed you to NUJ, cos this is not even NUJ press pass to begin with.



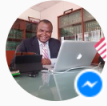
That's an example of NUJ press pass

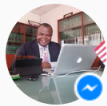

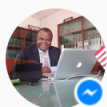

I don't know the full name for SSNR

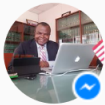
What does it stands for?

And why are we doing it before checking of name with CAC

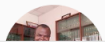
Just stay on them minute by minute. Maybe that will cause them to move faster

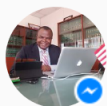

Do you mean to tell me you don't know the full name of SSNR?

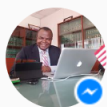
You see, we are lawyers. We register as directed by law. We don't often question who we have to register for this or that or why they chose this name or that name or this abbreviation or the other abbreviation



I want to hear it from you

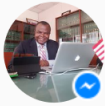
Kindly tell me please

Whoa!

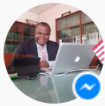
All I know is that the registration is required in order for you to appropriate a name for publication

It is past 1am. As a lawyer, I don't discuss cases with clients past 1am. So, good night please

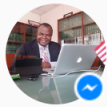

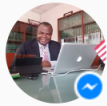

What's ISSN?

International Standard Serial Number (ISSN)

It is a way all publications are uniquely

It is a way all publications are uniquely identified for bibliographical purposes



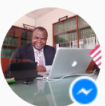
Good night

Why is that required before name availability check?

It is not that it is required before availability check. Each ISSN is tied to a name of a publication



That is how to ensure that different publications don't bear the same name and confuse readers



So, each name is tied to a number. When you want to start a magazine, the one way to know if another magazine in the world is using that name is to require you to register your magazine name for the purpose of assigning it a unique number

Barrister can we do the availability check first and reserve the name

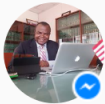

I don't understand it that way

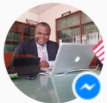
Please since you said its not required before availability check, kindly start with name availability check and registration tomorrow. I'm no longer enjoying the ISSN registration process

You should tell the cab driver where you want to go and leave him to get your there

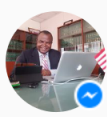
I'm not directing the procedure

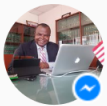

I understand, but I need to know. Because I don't understand the process you are using, ISSN is usually obtained under a publication name, which is already registered with the CAC ; but in this case you are obtaining ISSN before registration, so I'm confused! Under what publication are you obtain ISSN for EDO PEOPLE MAGAZINE?

Madam,  
I have carefully reviewed my communications with you over this matter. We were talking about registration of your Magazine, EDO PEOPLE MAGAZINE. I explained to you what the procedure was to get the name registered at ISSN. Nothing has changed in the procedure I outlined for you. Somehow, you got it mixed up that I was to incorporate an entity under that name. But that is not what we have been talking about and that is not the

procedure we have taken.

We pursued your ISSN registration which is vital for a publication - all publications. You became quiet aggressive and you issued a subtle threat in the following language: "Barrister Emeka please I need you to do the appropriate, otherwise I ll take necessary actions"

When you were sending this message or trying to reach me, I was in a cab heading to the airport in Abuja. First, in as much as I would like to help you, I do not yield to threats. You get the complete opposite result when you threaten me. I have done what I was asked to do. I run a law firm. Two lawyers were sent to reserve your name for ISSN and those lawyers are there to attest to their diligence. We have followed up since then. So, the notion that there was anything you could do to compel me is very very wrong.
