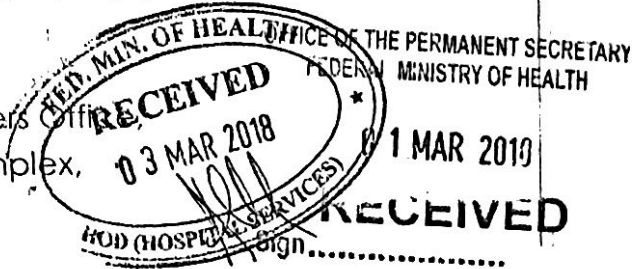

  - Copy of National Health Insurance Scheme Tenders Board's resolution on the award of Lot 1 contract for consultancy services for Risk Management, Lot 4 contract for consultancy service for media and special public relations, Lot 8 contract for Half Hour Radio magazine program in Hausa, Yoruba, Igbo and pidgin, Lot 18 contract for the purchase of National Health Insurance Scheme's project vehicle, Lot 19 contract for replacement of window blinds with wooden venetia type and procurement of

library books (e-books and periodicals) communicated to the office of the Hon. Minister of Health for implementation;
