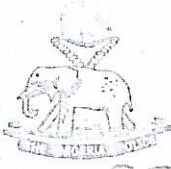



 at Obichukwu Nwoso Palace, where the
 same boys came in again, but every-
 body was alleging that it was them.
 Ned who mobilized them, and do the
 same to the elders. The third day Dis
 went and mobilized thugs from Onitsha
 and other places, everybody now started
 fighting. Everybody started shouting
 against others. Dis boys and Non-Dis
 boys were also showing guns. And
 when one Orada boy who I did not
 know his name came in with his motor-
 cycle. While one man called Eneke and
 Eyo stopped the Orada boy asking who
 are you? while the Orada boy was
 passing, the boys things Dis brought
 came in there and shot the Orada
 boy with a locally made pistol, which
 the Orada fell down and die immediately
 and Obichukwu Nwoso ordered the boys
 and his thugs to move his body away

I am NWOKO KEMAL, before the crisis I was a servant in the Palace at Prince Nwoso NWOKO; when the crisis started, before the family meeting at the Palace Prince Nwoso Okech NWOKO, the Crown Prince was calling people on phone that they want to see Hon. Nwoso NWOKO from the community, calling family meeting to discuss about this, when the elders gathered, the first day, the meeting could not hold, because uninvited guest that came to the meeting, so the meeting ~~was~~ ^{which} resulted to fighting and the meeting was postponed to the next day. On the next day, Denis Uwadiogwu called on Chetachukwu Okech Alias Asaba, how they can get some soldier boys to assist them in this fight, which Chetachukwu Okech Alias Asaba told Denis Uwadiogwu that if he bring money he can do that money was given to Chetachukwu Okech Alias Asaba, and he brought about thirty (30) people and they were kept in the Palace. The next morning which is the meeting, these uninvited guest came in again, and it's because of those uninvited guest they brought the soldier boys


P.T.O

Under the Oil Bombs Prince Asaba, and
 shot a double Barrel Gun in air, and
 the fight started in the community, the
 light boys that was brought by Chief
 Okoro Okoro Prince Asaba brought
 now shot the Okoro Okoro to death
 and his body was set ablaze
 Under Prince Uwadiogu Order some
 boys namely: Adim Nwani, Jimma
 and two other people, to find the deceased
 with a wheel barrow and dropped him
 by the road about, later at night, I

my properties were removed out of my house
they were all burnt. I know Cheta Churwu -
Okolo alias Asaba who is not an indigine
of Ugboko Community, he does nothing in
the village except farming. I know Dajisi
Esogor, he is an indigine of Ugboko Com-
munity and I know him as a farmer in the
village. During the crisis at Ugboko Community
by sometime in 2017, I recognized Cheta Chur-
wu Okolo as alias Asaba, both Cheta-
Churwu and Dajisi Esogor I recognized
them by coming double Barrel Gun which
they collected from my chairman of the
vigilante, by a name Peter Bama who
was held hostage in his house, I immediately
drove to Peter house, and drove to my
house, where I recognized Cheta Churwu -
Okolo alias Asaba, Esogor Dajisi, Agilize
Light, Felix Nwagwu Dajisi Esogor, Ejum-
for, Chelumbe Ndudi and many others
led by AIRHMND DMEZI who is already
in the prison in respect of this case.
The second day of the crisis, Early in
the morning two (2) L300 buses with
Asaba color, loaded with (with) boys
drove into Ugboko Community, from a

the palace, and that was a meeting that
 day but the meeting did not hold. One
 boy called Mwanza Onyachwale alias Abay-
 shuz of Double Bayell on air, then people
 started running, before the ^{cut} boy who
 was loaded from Asaba with ASABA color
 came out of the bus with a red clothe
 on his hand and they were all armed
 with different guns. When one Okada boy
 was shot down, which I later discovered
 that he was Cyprian, I was hiding
 inside one uncompleted building watching
 everything that is happening, where the
 body of the deceased Cyprian was ta-
 king from there to the ground about with

That I Nwogu Chukwuma of the above named address wish to state as follows. I was born and brought up in Ugboko Community in Aniocha - North Local Government Area of Delta State. That I am a student of Department of Sociology, Novenna University located at Amai in Delta State. I know one Chetachukwu Okolo popularly known as Asaba. He lives at Ogbe/Obi (Owu) Quarters in Ugboko Community. He is a member of the vigilante group organised by one Prince Chukwunonso Nwoko. That during the crisis in 2017, the said Chetachukwu Okolo alias Asaba was actively involved. He was using machet and vigilante locally-made gun issued to him with Onyisi Esuzor to harass people in the Community. Chetachukwu Okolo alias Asaba and Onyisi Esuzor and their gangs moved at night around 12 am to 1 am destroy people houses such as Chukuma Nwoko's house, Omezi Eziokwu house, Chris Ogwu's house, Appear Nwoko house and others. The said Chetachukwu Okolo alias Asaba and gang also destroyed cars, motorcycles and laptops belonging to the above named persons. The next day, one motorcycle rider name unknown was shot dead (at the) in front of the Palace by

Chetachukwu Okolo alias Asaba and his gang. After killing the motorcyclist, the dead body was left in front of the Palace while his motorcycle was burnt to ashes. Later in the day, the said Chetachukwu Okolo popularly known as Asaba and his gang took the corpse of the dead motorcycle rider to the Center of the town called "Abuano" and dump the corpse there. The next day at around 12 am, One Mr. Dennis Nwoko also known as Nwadiagu called Chetachukwu Okolo alias Asaba and his gang wherein they planned and removed the corpse of the motorcyclist and took it to the Palace, where they dug a pit and buried the corpse. The reason why Chetachukwu Okolo alias Asaba and Onyisi Esuzor's name were not mentioned at the initial stage of the investigation was that, the names of their sponsors were only captured. Onyisi Esuzor and Chetachukwu Okolo alias Asaba were fully involved in the crisis as the Major Characters. That's all my statement. ~~Chetachukwu~~ 05/08/2020

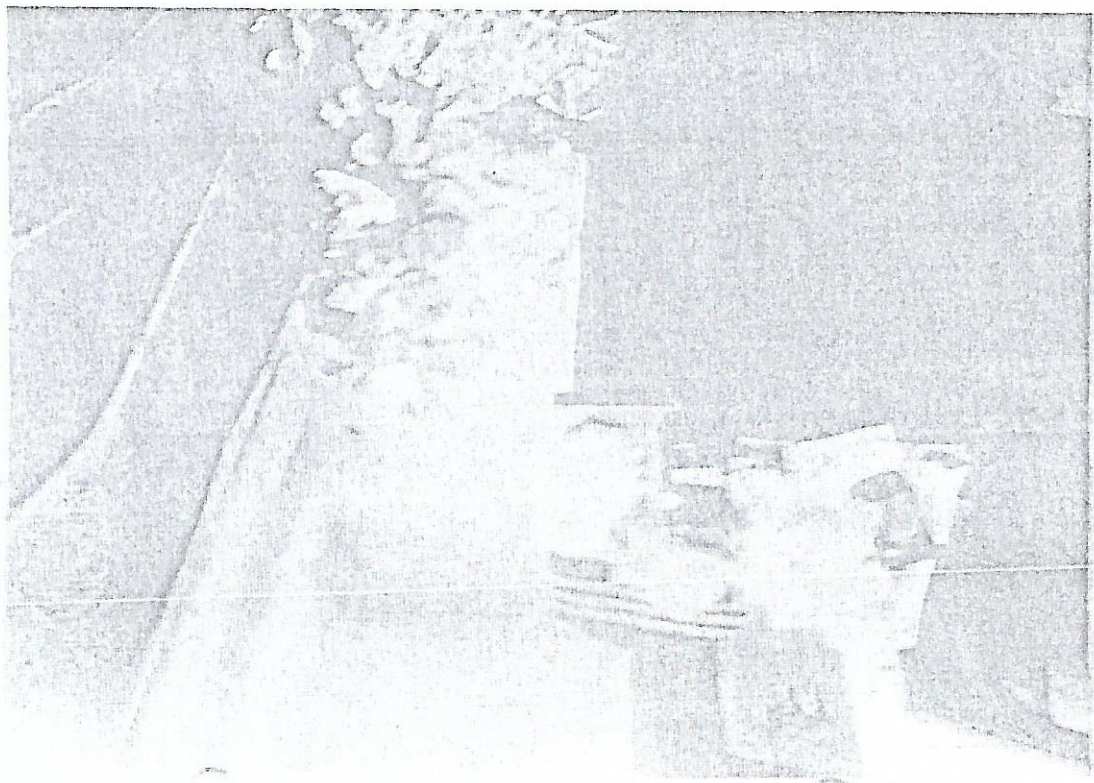
